Dufferin County

2023-2024

The Community Homelessness Report (CHR) is an annual Reaching Home reporting deliverable that supports communities to prevent and reduce homelessness using a more coordinated, systems-based and data-driven response. The CHR was designed to support local discussions and decision making, using all of the information about homelessness currently available at the community level. Communities are encouraged to use their CHR data to develop clear plans of action that help them to reach their homelessness reduction targets and to leverage the collective efforts of service providers working across the community, regardless of how they are funded.

This is a summary of the CHR for the 2023-24 reporting cycle. It shows the community's self-assessment of Reaching Home implementation, which includes the following key components:

- meaningful collaboration between Indigenous and non-Indigenous partners (see Section 1);
- community-level governance, coordinated service delivery (Coordinated Access) and use of a Homelessness Management Information System or HMIS (see Section 2); and,
- an Outcomes-Based Approach (tracking community-level outcomes and progress against targets using person-specific data; see Section 3).

If the community was able to report on outcomes and targets, this CHR Summary also includes results for each of the five core outcomes of Reaching Home (see Section 4).

Our Indigenous organization (White Owl Native Ancestry) was a previous co-chair of our CAB and was participating in weekly Coordinated Access Table (CAT) meetings. All policies for Coordinated Access were approved by our local Indigenous organization before implementation to ensure that they are culturally appropriate and inclusive of all diverse groups. All clients identified as Indigenous were referred to the Indigenous organization for additional supports. As of November 1, 2023 White Owl Native Ancestry went through some restucturing and stepped away from both the CAB and the CAT table. We are currently in discussions to ensure Indigenous representation is back at both tables.

Describe how this collaboration will happen over the coming year in more detail.

Due to restructuring at White Owl Native Ancestory, our ongoing collaboration ended as of November 1, 2023. Currently the CE is actively looking for new indigenous partnership to sit at both CAB and CAT and to provide input into our Coordinated Access System and to our Outcomes-Based Approach.

All Reaching Home funded projects and all Homelessness Prevention Program funded agencies are currently using HIFIS for data collecton and reporting. Currently working with Services and Housing in the Province to onboard staff to HIFIS for the new Supportive Housing at 236 First St. Due to new supportive housing units opening in Dufferin with dedicated units for the BNL and Coordinated Access clients we are currently developing the vacancy matching, referral challenges and refusal processes for this program. Currently working to improve on our data collection regarding housing history and to move towards pulling the BNL directly out of HIFIS. Working with our local Dufferin County Equity Collaborative (DCEC) and working with the Voices table for lived experience is being explored.


Describe the process(es) used by service providers to collect and enter data about people currently experiencing homelessness into the database.
