



## Rebate for Residential Condominium Corporations

The County of Dufferin will consider providing a rebate toward the cost of private waste collection for a residential condominium corporation that does not use curb side garbage collection.

To be eligible, the residential condominium corporation must:

- Participate in the County's waste diversion programs, including the Blue Box and Green Bin programs, as well as other programs where applicable for special collection wastes
- Make its intention to apply known no later than January 20<sup>th</sup> of the calendar year for which the rebate will apply (Section 3 of this form)
- Submit copies of invoices for the previous calendar year by January 20<sup>th</sup> (Section 2 of this form)
