

Application for Diaper Exemption

The County of Dufferin will consider making an exemption to the weekly bag limit for residents who have two (2) or more infants/children under the age of four (4) that are in diapers. Approved applicants will receive bag tags to cover one (1) extra garbage bag (to be filled with diapers only) for a period of **six (6) months**. An application must be completed every six months for continued service.
